On June 28, 2016, the Reporting Issuer's Board of Directors declared stock dividend, payable to shareholders of record as of July 8, 2016 and issued on July 18, 2016.

The stock dividend equates to an annualized distribution rate of 1% or .01 of a share for each share held.


