On June 25, 2013, the Reporting Issuer's Board of Directors declared stock dividend, payable to shareholders of record as of July 12, 2013 and issued on July 24, 2013.

The stock dividend equates to an annualized distribution rate of 1% or .01 of a share for each share held.
